THE EXECUTIVE SESSION OF THE BOARD OF COMMISSIONERS WAS HELD AT 8:00 A.M. PRESENT WERE COMMISSIONER PHILLIP MARSHALL, COMMISSIONER TODD EWEN, COMMISSIONER RICK ROBERTS, ATTORNEY APRIL GELTMAKER, AND AUDITOR KYRA STEPHENSON. THE MEETING WAS OPENED WITH THE PLEDGE TO THE FLAG BY COMMISSIONER EWEN FOLLOWED BY A PRAYER LED BY PRESTON SHELL.

**IT CONTRACT**

BILL BRADFORD WITH ALL TECHNOLOGY PRESENTED A RENEWAL CONTRACT FOR I.T. SERVICES. THE CONTRACT WILL EXPIRE IN APRIL OF 2027 AND IS IN THE AMOUNT OF \$11,000.00. COMMISSIONER ROBERTS MADE A MOTION TO ACCEPT THE CONTRACT FROM ALL TECHNOLOGY FOR THE THREE YEARS AT \$11,000.00. MOTION WAS SECONDED BY COMMISSIONER EWEN. MOTION PASSED.

**ORDINANCE AMENDING ORDINANCE 2016-01 ANIMAL DRAWN VEHICLE LICENSING FEE**

THE COMMISSIONERS REQUESTED SUPERINTENDENT CLODFELTER TO APPLY FOR A GRANT THAT WOULD HELP WITH THE COST OF REMOVING THE LOG JAM.


**BZA BOARD APPOINTMENT**


